The tuition balance is payable annually, semiannually or quarterly. Quarterly installments will have a finance charge of \$15.00 per payment. Payments received ten days after the due date will be subject to a \$30.00 late fee. Additional fees will be assessed for delinquent payments. All tuition is to be paid in Full by March 1 unless specific contract arrangement is made.
